

# Job summary

**Role title:** IT Technical Analyst

**Department:** ICT

## General description of role

Reporting to the Technical Team Leader, this is a hands-on role with responsibilities for a wide range of core and distributed infrastructure including Desktop, Telephony, Storage, Security, Network, Virtualisation and Disaster Recovery. The role includes 3<sup>rd</sup> line problem solving, change management and technical project delivery in line with Technical Team skill matrix requirements.

- To develop and maintain a forward looking and resilient technology architecture for the council.
- To complete project work, participate on project boards and ensure change control processes are adhered to.
- To assist with the provision of a Technical Design Authority to ensure compliance with the Corporate ICT Strategy and other relevant Council strategies.
- To provide a 3<sup>rd</sup> line technical resolution service for incidents allocated by the Service Desk team.
- Technical support of core and distributed infrastructure and systems, ensuring an excellent level of customer support and efficient delivery of technical projects
- The quality and reliability of server rooms, core infrastructure hardware, network equipment, telephony equipment, data security and distributed infrastructure.
- Ensuring that Disaster Recovery can be invoked in accordance with stated aims and documented processes.
- Ensuring that incidents and service requests are updated on the system, SLAs are adhered to, customers and the Service Delivery Manager are updated regularly, and escalation processes are followed
- Ensuring the coordination of issues with 3rd party expertise is handled effectively

## Top ten duties / responsibilities of role

1. Contribute to ICT architectural design and roadmaps, ensuring that appropriate choices are made in accordance with the ICT Strategy.
2. Provide a support service for ICT customers resolving issues of a complex nature.
3. Provide 3<sup>rd</sup> Line support expertise and Technical Project delivery input to ensure the integrity and quality of the technology architecture and services.
4. Ensure that monitoring of servers, storage, network, security, backups and associated equipment are performed effectively.
5. Data centre design and supervision including the monitoring of servers, storage and associated equipment, secondary platforms and communications internally and externally.
6. Contribute, as requested, on project boards for technology projects ensuring best practise and ICT strategic standards are maintained during the project design and delivery phases.
7. Produce technical specifications as required to enable procurement processes to be undertaken.
8. Work with suppliers and partners to ensure that services are kept up to date and supportable.
9. Investigate emerging technologies, products, methods and techniques to assess their potential benefit within the scope of ICT technical strategy.
10. Produce documentation and manage handover to the Service Desk in a way that ensures efficient and supportable establishment of new services.



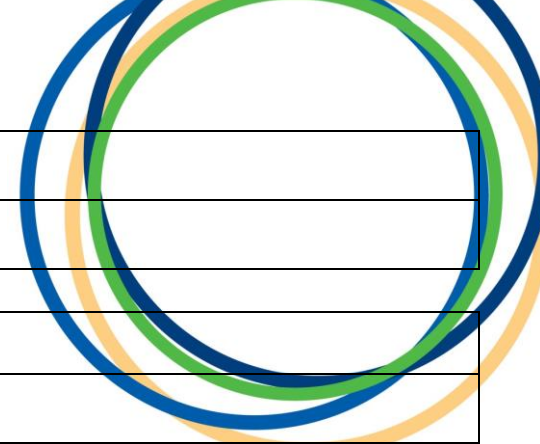

# Summary of employment package

<b>Place of work</b>	The role will be primarily based at <b>Town Hall, Reigate/Hybrid Working</b> We may require you to work from another place of work within the Borough or a neighbouring Borough or District, or further afield by prior agreement.
<b>Salary</b>	Graded <b>Technical Specialist</b> , the salary will be in the region of <b>£34,944- £43,788</b> per annum dependent upon experience. Cost of living awards are reviewed annually on 1 April. Incremental progression and bonuses may be payable in line with the appraisal scheme.
<b>Duration of contract</b>	The contract will be offered on a permanent basis.
<b>Probationary period</b>	Upon joining the Council, all staff are required to satisfactorily complete a six month probationary period.
<b>Hours of work</b>	Hours of work are nominally 36 per week.
<b>Employment Benefits</b>	
<b>Flexible working hours</b>	Flexible working allows for the alteration of start/leave times and length of lunchtime break, time off in lieu for longer hours worked and a flexible working system. Whilst staff are expected to manage their time and keep working hours within acceptable limits, flexible working arrangements are always subject to sufficient office cover and the particular needs of the service at that time.
<b>Annual leave</b>	The basic leave entitlement is 259.2 hours per annum pro rata (equivalent to 36 standard days), rising to 295.2 hours per annum (equivalent to 41 standard days) pro rata after five years continuous local government service, inclusive of Bank Holidays. Annual leave must be taken on the Council's discretionary day off around Christmas and New Year period.

<p><b>Pension</b></p>	<p>You will be auto enrolled into the Local Government Pension Scheme (LGPS) to which the Council contributes 15% of your earnings each year.</p> <p>You are able to transfer funds into the LGPS within the first twelve months of employment. However, you can also choose not to join the scheme and make your own arrangements. If you wish to opt out of the scheme you will not be able to do so until after your first day.</p> <p>Your pension contribution rate will depend on your full time equivalent annual salary. The salary and rates are reviewed annually on 1 April each year. <p><b>Training and development</b></p>	<p>The Council actively encourages continued professional development and talent development.</p> <p>Learning facilities are available in-house, including a dedicated Training Room for both individual and group learning. The Council also has a number of Computer Based Training packages.</p>
<p><b>Professional subscriptions</b></p>	<p>If you are required to be a member of a professional organisation(s) for your role, we will pay the subscription fee(s) each year directly by invoice.</p>
<p><b>Car parking / Travel loan scheme</b></p>	<p>Unless your role is classed as an essential user, you take part in our car share scheme, or you are physically disabled, car parking is not made available.</p> <p>The Council offers interest free loans to encourage staff to travel by alternative methods to solo car use. Loans are available to purchase bicycles and accessories to the value of £1000, for quarterly/yearly rail season or bus tickets or a season car park pass.</p>
<p><b>Cycle purchase scheme</b></p>	<p>The Council offers staff who have passed the probation period and are employed for 18 months or more, the opportunity to lease/purchase bikes and related safety equipment up to £1000, reducing tax and National Insurance deductions. Staff are required to use the bike mainly for journeys between home and work.</p>
<p><b>Employee discounts</b></p>	<p>All staff have access to special offers and discounts on national and local high street shops, restaurants, motoring benefits, discount cinema and theatre tickets, holidays, insurance and much more.</p> <p>Full annual discounted membership is available for the 'Better' run leisure centres at Tadworth, Donyngs and Horley.</p>
